## 1 Introduction

MeDirect Bank (Malta) plc uses cookies to ensure optimal usage of our services and website. Cookies from MeDirect Bank (Malta) plc are safe for your computer, laptop, tablet or smartphone. In this cookie policy, we are providing information about the different applications of cookies and how they are used on the MeDirect Bank (Malta) plc website ([www.medirect.com.mt](http://www.medirect.com.mt)).

## 2 What are Cookies?

Cookies are small pieces of text sent to your web browser by a website you visit. A cookie file is stored in your web browser and allows the service or a third party to recognise you and make your next visit easier, by providing a service that is more useful to you.

## 3 What are Cookies used for?

Cookies are used to collect information about how you interact with our website, as well as web-related products and services. Cookies help us understand what you like and do not like about our website. With cookies, we are able to provide a more enjoyable and customised experience for our clients.

## 4 Which Cookies are used?

Cookies may be split into two broad categories based on their lifespans, as follows:

- **Session:** Those cookies that are erased when a user closes a browser. Session cookies enable us to track the use of our website and to analyse and evaluate the effectiveness of our marketing campaigns and activities. The information collected through these cookies is not stored and cannot be used to identify you as an individual. We do not share the information gathered through Session cookies with third parties.
- **Persistent:** Those cookies that remain on the users' computer for a predesignated period.
